Rules and Regulations for Golf Activity at the club:

1. Dress Code – No Tank Tops, Shirts with sleeves and/or collars, **No Metal Spikes**
2. Maximum of 4 players per group. Each player must have or rent their own set of clubs
3. Rental power carts are available. Drivers must have a driver's license. Maximum of 2 people and 2 sets of clubs per cart
4. **Due to LCBO regulations, No Private Coolers or Containers containing alcoholic beverages are legal on this course.** Beverages can be purchased at the club house or from the beverage cart. **The parking lot and boat dockage areas are "out of bounds" for alcohol consumption.**
5. As your group organizer, you, or your designated representative, shall provide assistance to the club staff, if requested, in ensuring that the club rules are followed.

Application for Group Golf Activity (con't)

To avoid delays at golf outings, a group of 20 or more non-member players must have a group representative collect the golfing green fees prior to tee time. The total fee for non-members must then be turned in to the Pro Shop prior to the start of play. Our staff can provide your representative(s) with a table and chairs for a collection station in a suitable area. Cart fees will be paid for in the Pro Shop in the usual manner.

It would be appreciated if two copies of the final list of players could be supplied to the Pro Shop staff prior to the play date. As well, if a list of players coupled up for carts would help us prepare for your day of golfing.
